Annual Report – May 26, 2020

Not-for-Profit Corporation: The St. Andrew Lutheran Church Foundation is a not-for-profit corporation established by the St. Andrew Lutheran Church congregation as a supporting organization.

Purposes: The purposes for which the Foundation is organized are exclusively religious, charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code, such purposes being more specifically set forth as follows:

- To provide lasting financial resources for educational, charitable and religious outreach and ministry both today and into the future in ways that are beyond the capability of the mission and ministry fund.
- To augment the financial resources otherwise available to support the programs, mission and ministries of St. Andrew Lutheran Church.
- To fulfill the Legacy wishes of donors when special contributions are given and accepted with conditions or restrictions attached, but are in keeping with the congregations' programs, mission and ministries.
- To provide start-up funding or additional funding for ministry programs or outreach efforts deemed important to the congregation in fulfilling its mission to members, the surrounding community or the world at large. This may include grants to other 501(c)(3) organizations responding to real human needs.

In other words... to provide funding for ministry that otherwise is only dreamt about!

What the Foundation does to fulfill its purpose:

- Receives, accepts, holds, invests, reinvests and administers gifts from congregation members and others including, but not limited to cash, bequests, devises, benefits of trusts, proceeds from life insurance and annuities, property of any sort or distributions from retirement plans.
- Retains the majority of gifts received in a permanent endowment (unless otherwise instructed by the donor), distributing the interest, dividends and gains generated therefrom as determined by Foundation's Board of Directors.

Foundation's 2019-2020 Accomplishments:

- Acknowledge donors regularly, with thank-you cards and other methods
- During the last year distributions have been made in the form of:
 - High School Scholarships for 2020 graduates: Congratulations to Dominic Hooson, Emily Moore, and Anneliese Bishop-Purdue
 - Camp Lutherwood, to support their ministry and rebuilding of the burned hall: \$2,000
 - Organ Lesson Scholarship: \$800
 - Life insurance payments (2): \$12,000 total
 - Earth Camp startup funding: \$1,000
 - Liturgical Art for the St. Andrew sanctuary and narthex: \$350
 - Family Promise, to support the successful purchase of the day center house: \$2,000
 - Oregon Chorale: \$200

The Foundation's Vision for 2020-2021

- Continue to diversify the membership of the Board of Directors
- Grant scholarships to support seminarians, post-high school education, and church organ lessons
- Continue to make grants to community organizations

- Support events that represent our mission and values
- Conduct a facilitated strategic planning session
- Update and approve Foundation bylaws and other documents
