INSTRUCTIONS FOR TRANSFERRING SECURITIES TO ST. ANDREW'S ACCOUNT AT CHARLES SCHWAB

- 1. To transfer securities (stock/bonds) from your brokerage firm to St. Andrew's Charles Schwab account, you must provide, in letter form, the **following information** to the brokerage firm from which the securities are being transferred. *We cannot complete this for you.*
 - 1. The number of shares and name (description) of what is to be transferred (i.e. 120 shares of Intel Corp);
 - 2. The account number from which the security is being transferred;
 - 3. That the securities are to be transferred to the St. Andrew Lutheran Church account #8175-4769 at Charles Schwab;
 - 4. Reference the DTC number for Charles Schwab. It is 0164; Code 40
 - 5. State the purpose of the gift (i.e. Ministry and Mission, Building/Mortgage, etc.) including the amounts to each account.
 - 6. If the account from which the securities are being transferred is a joint account (more than one owner), then all owners must sign the letter of instruction;
- 2. Please provide a copy of this completed form plus all related correspondence to the Financial Secretary of St. Andrew Lutheran Church at the beginning of this process (see other side).

3. Allow enough time for the transfer to be completed by Dec. 31st in order for the stock donation to be counted for the current tax year.
